



Across the United States, almost 8.5 million locations lack access to high-speed Internet service. **The Biden Administration’s Investing in America agenda aims to bridge this divide and connect everyone in America with affordable, reliable, high-speed Internet service.** Last year, the Administration launched the **Internet for All** initiative with \$65 billion from President Biden’s Bipartisan Infrastructure Law, \$25 billion from the President’s American Rescue Plan, and several other high-speed Internet programs. **Internet for All** will deliver high-speed Internet infrastructure to every corner of the country, enable working families to afford service, and ensure that everyone has the digital skills and devices they need to fully utilize the Internet. Together, we will close the digital divide and grow our economy from the bottom up and middle out.

\$1,040,420,751.50*	The Broadband Equity, Access, and Deployment (BEAD) Program provides \$42.45 billion from President Biden’s Bipartisan Infrastructure Law to expand high-speed Internet access by funding planning, infrastructure deployment, and adoption programs across the country. *\$5,000,000.00 already awarded for Internet infrastructure planning. \$63,836,266.43*	The Coronavirus State and Local Fiscal Recovery Funds (SLFRF) program, funded by President Biden’s American Rescue Plan Act, delivers \$350 billion to state, territorial, local, and Tribal governments across the country to support their response to and recovery from the COVID-19 pandemic, including high-speed Internet deployment. *Figure represents dedicated high-speed Internet funding. \$253,680,000.00*	The Capital Projects Fund (CPF) provides \$10 billion from President Biden’s American Rescue Plan to states, territories, freely associated states, and Tribal governments to fund critical capital projects that enable work, education, and health monitoring in response to the public health emergency, including high-speed Internet infrastructure. *Figure represents dedicated high-speed Internet funding. \$106,514,667.00	The ReConnect Loan and Grant Program is a \$1.9 billion program funded through President Biden’s Bipartisan Infrastructure Law that provides funds for the cost of construction, improvement, or acquisition of facilities and equipment needed to provide high-speed Internet service in eligible rural areas. \$14,557,740.21	The Enabling Middle Mile Broadband Infrastructure Program provides \$1 billion from President Biden’s Bipartisan Infrastructure Law to reduce the cost of bringing high-speed Internet service to unserved and underserved communities by connecting local networks to major networks.	NTIA, Department of Commerce
\$4,947,163.00	The Community Connect Grants is a grant program which received \$35 million in the FY23 appropriations bill, that provides funding for eligible applicants to construct high-speed Internet networks on a community-oriented connectivity basis in rural areas.	Department of Agriculture
