



Across the United States, almost 8.5 million locations lack access to high-speed Internet service. **The Biden Administration’s Investing in America agenda aims to bridge this divide and connect everyone in America with affordable, reliable, high-speed Internet service.** Last year, the Administration launched the **Internet for All** initiative with \$65 billion from President Biden’s Bipartisan Infrastructure Law, \$25 billion from the President’s American Rescue Plan, and several other high-speed Internet programs. **Internet for All** will deliver high-speed Internet infrastructure to every corner of the country, enable working families to afford service, and ensure that everyone has the digital skills and devices they need to fully utilize the Internet. Together, we will close the digital divide and grow our economy from the bottom up and middle out.

\$797,435,691.25*	The Broadband Equity, Access, and Deployment (BEAD) Program provides \$42.45 billion from President Biden’s Bipartisan Infrastructure Law to expand high-speed Internet access by funding planning, infrastructure deployment, and adoption programs across the country. *\$5,000,000.00 already awarded for Internet infrastructure planning. \$205,511,253.99	The Tribal Broadband Connectivity Program (TBCP) is a \$3 billion program, from President Biden’s Bipartisan Infrastructure Law and the Consolidated Appropriations Act, to support Tribal governments bringing high-speed Internet to Tribal lands, including telehealth, distance learning, affordability, and digital inclusion initiatives. \$209,387,141.00	The ReConnect Loan and Grant Program is a \$1.9 billion program funded through President Biden’s Bipartisan Infrastructure Law that provides funds for the cost of construction, improvement, or acquisition of facilities and equipment needed to provide high-speed Internet service in eligible rural areas.	Department of Agriculture
\$14,547,482.42	The Enabling Middle Mile Broadband Infrastructure Program provides \$1 billion from President Biden’s Bipartisan Infrastructure Law to reduce the cost of bringing high-speed Internet service to unserved and underserved communities by connecting local networks to major networks.	NTIA, Department of Commerce
\$10,233,000.00	The Telecommunications Infrastructure Loan Program is a \$690 million program which provides low-interest loans to construct, maintain, improve, and expand telephone and broadband services in rural areas.	USDA
\$9,611,804.00	The Community Connect Grants is a grant program which received \$35 million in the FY23 appropriations bill, that provides funding for eligible applicants to construct high-speed Internet networks on a community-oriented connectivity basis in rural areas.	Department of Agriculture

\$126,622,033.73	The Emergency Connectivity Program funded by President's Biden's American Rescue Plan Act provides \$7.171 billion to support Internet services and connected devices for students, school staff, and library patrons in communities across the country.	Federal Communications Commission
\$882,087.78	The Digital Equity Act provides \$2.75 billion to establish three grant programs that promote digital equity and inclusion.	NTIA, Department of Commerce
\$3,705,568.22	The Connecting Minority Communities Pilot Program (CMC) provided \$268 million to help colleges and institutions that serve minority and Tribal communities.	NTIA, Department of Commerce

\$178,465,941.00	The Affordable Connectivity Program (ACP) provides \$14.2 billion from President Biden's Bipartisan Infrastructure Law to provide eligible households with a discount of up to \$30/month (\$75/month on qualifying Tribal lands) for high-speed Internet service, and up to \$100 discount toward a desktop, laptop, or tablet computer offered by participating Internet service providers.	288,725
